## The EU has recognized labour inclusion as one of the pillars of migrants' integration.

The Work4Integration - Europe project involves public, private, profit and non-profit actors from Italy, Sweden and Belgium in **developing a comprehensive approach to support employment and vocational training, promoting the labour market integration of migrants.**

In addition, it promotes **exchanges between different national systems, in order to compare integration models and enhance their strengths.**

**Work4Integration Europe project addresses migrants and companies in Italy, Belgium and Sweden.**

## Goals

1. **To promote** an effective process of integration of migrants into the labour market.
2. **To involve** employers and other key actors in the process of migrants' labour integration.
3. **To exchange** good practices and methodologies among the partners.
4. **To develop** a multistakeholder strategy and promote the elaboration of a unified model for the labour inclusion of migrants to be proposed at the European level.

## Activities

1. **For the migrants:**  
skills assessment, vocational training courses, promotion of job opportunities, multidisciplinary services, cultural-linguistic mediation, tutorship and follow up.
2. **For the companies:**  
awareness and information on the migratory phenomenon, accompaniment in the employment of foreign staff, legal and diversity management support, promotion of the exchange of good practices.
